AN ORDINANCE AMENDING ORDINANCE NO. 218 of 1986, OF THE BOROUGH OF NORTH APOLLO, ARMSTRONG COUNTY, PENNSYLVANIA, ENACTED OCTOBER 6, 1986, RELATING TO THE LOCATION AND USE OF STRUCTURES AND LAND RESIDENCES, BUSINESSES, INDUSTRIES, AND OTHER PURPOSES.
